## Partner Update – Riverside County Housing & Workforce Solutions (RCH&WS)

The City of Moreno Valley and the Riverside County HWS Department have joined forces to collaborate at the BERC. The objective of this partnership is to offer job seekers training and resources, career counseling, America Job Center support for City staff, business services, and incumbent worker training. During a presentation to the committee and staff, Stephanie Adams, the Deputy Director of RCH, provided updates on the comprehensive range of services they offer and the centers they have throughout Riverside County, including one located in the heart of Moreno Valley. Ms. Adams also shared some statistics on the number of career services provided through the BERC, such as 5,611 walk-ins, 164 new participants enrolled in various programs, 74 residents receiving career technical training, with programs such as Nursing Assistants, Welding, Carpentry, and many more. Moreover, in Business Services, 63 local businesses received on-the-job training.

# **Business & Employment Resource Center (BERC) Update (Keith Gemmell)**

Keith Gemmell, BERC Division Manager, provided an overview of the performance of business development, workforce development, and outreach events, including key milestones for November 2023. One significant milestone is the expansion of veteran training with off-base transitional training.

City staff organized a number of successful hiring events in collaboration with our partners, including Caltrans, which had 45 positions available; UC Riverside, which had 40 positions available; and the National Apprenticeship Week Expo, which served approximately 600 high school students from the Inland Empire region. Amazon also hosted a hiring event with 25 positions available.

Additionally, the BERC has renewed its contract with Google, which has allowed us to provide an additional hundred Google Career Scholarships. Our staff is currently preparing for the marketing. These scholarships are free and are being offered to our residents for free. In total, the value of these scholarships is around \$60,000.
