

HOW TO QUALIFY?

You may qualify for a Utility Users' Tax Exemption if the combined gross income of all members of your household is less than 65% of the median household income for the County of Riverside as defined by HUD.

Proof of "gross household income" must be submitted with your application.

For UUT Exemption, the definition of "gross (before taxes) household income" is all money and non-cash benefits, available for living expenses, from all sources, both taxable and non-taxable, before deductions, for all people who live in the residence. This includes, but is not limited to, the following:

- Wages or salaries (at least two current check stubs or four check stubs if paid weekly)
- Bonuses, tips
- Gross amounts of pensions and/or annuities
- Interest or dividends from savings accounts, stocks/bonds, or retirement accounts
- Retirement benefits
- Social security, SSI, SSD
- Unemployment benefits
- Prior year's income tax refunds
- Disability payments
- Life insurance benefits
- Capital gains
- Inheritances
- Scholarships, grants, or other aid used for living expenses
- Child support
- AFDC
- Food stamps
- Foster care payments
- Workers' compensation
- Insurance settlements
- Legal settlements
- Cash
- Spousal support
- Other support

When submitting your application for an exemption from the Utility User's Tax, remember to enclose gross household income, sign and date your application.
