## 2024 San Bernardino County and Riverside County Affordable Housing Worksheet

### 1. Income Eligibility<sup>1</sup>

The first step in determining eligibility for an affordable housing program is determining whether the family which will be purchasing or renting the housing unit meets the following income standards applicable to San Bernardino County and to Riverside County, based upon the size of the family:

## 2. Determining Affordable Housing Cost

For **ownership housing**, the second step in determining compliance with affordable housing requirements is determining whether the total housing costs payable by the buyer are within allowable amounts.

For **Extremely Low Income Buyers**:<sup>2</sup>

- purchasing a **0 bedroom** house, monthly housing payments may not exceed **\$511.88**
- purchasing a **1 bedroom** house, monthly housing payments may not exceed **\$585.00**
- purchasing a **2 bedroom** house, monthly housing payments may not exceed **\$658.13**
- purchasing a **3 bedroom** house, monthly housing payments may not exceed **\$731.25**
- purchasing a **4 bedroom** house, monthly housing payments may not exceed **\$789.75**
- purchasing a **5 bedroom** house, monthly housing payments may not exceed **\$848.25**

For **Very Low Income Buyers**:<sup>3</sup>

- purchasing a **0 bedroom** house, monthly housing payments may not exceed **\$853.13**
- purchasing a **1 bedroom** house, monthly housing payments may not exceed **\$975.00**
- purchasing a **2 bedroom** house, monthly housing payments may not exceed **\$1,096.88**
- purchasing a **3 bedroom** house, monthly housing payments may not exceed **\$1,218.75**
- purchasing a **4 bedroom** house, monthly housing payments may not exceed **\$1,316.25**
- purchasing a **5 bedroom** house, monthly housing payments may not exceed **\$1,413.75**

For **Lower Income** Buyers:<sup>4</sup>

- purchasing a **0 bedroom** house, monthly housing payments may not exceed **\$1,194.38**
- purchasing a **1 bedroom** house, monthly housing payments may not exceed **\$1,365.00**
- purchasing a **2 bedroom** house, monthly housing payments may not exceed **\$1,535.63**
- purchasing a **3 bedroom** house, monthly housing payments may not exceed **\$1,706.25**
- purchasing a **4 bedroom** house, monthly housing payments may not exceed **\$1,842.75**
- purchasing a **5 bedroom** house, monthly housing payments may not exceed **\$1,979.25**

In addition, for any Lower Income Household buyers whose income falls within the following guidelines, it is **optional** for the agency to require that **affordable housing cost not exceed 30 percent of the gross income of the household:**<sup>5</sup>

- **1 person households** whose income is between **\$47,775 and \$57,400**
- **2 person households** whose income is between **\$54,600 and \$65,600**
- **3 person households** whose income is between **\$61,425 and \$73,800**
- **4 person households** whose income is between **\$68,250 and \$82,000**
- **5 person households** whose income is between **\$73,710 and \$88,600**
- **6 person households** whose income is between **\$79,170 and \$95,150**
- **7 person households** whose income is between **\$84,630 and \$101,650**
- **8 person households** whose income is between **\$90,090 and \$128,700**

For **Moderate Income** Buyers:<sup>6</sup>

- purchasing a **0 bedroom** house, monthly housing payments may not exceed **\$2,189.69**
- purchasing a **1 bedroom** house, monthly housing payments may not exceed **\$2,502.50**
- purchasing a **2 bedroom** house, monthly housing payments may not exceed **\$2,815.31**
- purchasing a **3 bedroom** house, monthly housing payments may not exceed **\$3,128.13**
- purchasing a **4 bedroom** house, monthly housing payments may not exceed **\$3,378.38**
- purchasing a **5 bedroom** house, monthly housing payments may not exceed **\$3,628.63**

In addition, for any Moderate Income Household buyers whose income falls within the following guidelines, it is **optional** for the agency to require that **affordable housing cost not exceed 35 percent of the gross income of the household:**<sup>7</sup>

- **1 person households** whose income is between **\$75,075 and \$81,900**
- **2 person households** whose income is between **\$85,800 and \$93,600**
- **3 person households** whose income is between **\$96,525 and \$105,300**
- **4 person households** whose income is between **\$107,250 and \$117,000**
- **5 person households** whose income is between **\$115,830 and \$126,350**
- **6 person households** whose income is between **\$124,410 and \$135,700**
- **7 person households** whose income is between **\$132,990 and \$145,100**
- **8 person households** whose income is between **\$141,570 and \$154,450**

**For purposes of determining Affordable Housing Cost, “Monthly Housing Payments”** include an estimate of the following costs for the upcoming twelve months:<sup>8</sup>

- principal and interest payments on the mortgage loan, including rehabilitation loans
- mortgage loan insurance fees
- property taxes and assessments
- fire and casualty insurance
- property maintenance and repairs
- a reasonable allowance for utilities (including garbage collection, sewer, water, electricity, gas and other fuels, but not telephone service). Such an allowance shall take into consideration the cost of an adequate level of service.
- homeowner association fees
- space rent, if the housing unit is on rented land

### **3. Determining Affordable Rent**

For **rental housing**, the second step in determining compliance with affordable housing requirements is determining whether the total rent costs payable by the tenant are within allowable amounts.

For **Acutely Low Income** Households:<sup>9</sup>

- renting a **0 bedroom** unit, monthly rent may not exceed **\$255.94**
- renting a **1 bedroom** unit, monthly rent may not exceed **\$292.50**
- renting a **2 bedroom** unit, monthly rent may not exceed **\$329.06**
- renting a **3 bedroom** unit, monthly rent may not exceed **\$365.63**
- renting a **4 bedroom** unit, monthly rent may not exceed **\$394.88**
- renting a **5 bedroom** unit, monthly rent may not exceed **\$424.25**

For **Extremely Low Income** Households:<sup>10</sup>

- renting a **0 bedroom** unit, monthly rent may not exceed **\$511.88**
- renting a **1 bedroom** unit, monthly rent may not exceed **\$585.00**
- renting a **2 bedroom** unit, monthly rent may not exceed **\$658.13**
- renting a **3 bedroom** unit, monthly rent may not exceed **\$731.25**
- renting a **4 bedroom** unit, monthly rent may not exceed **\$789.75**
- renting a **5 bedroom** unit, monthly rent may not exceed **\$848.25**

For **Very Low Income** Households:<sup>11</sup>

- renting a **0 bedroom** unit, monthly rent may not exceed **\$853.13**
- renting a **1 bedroom** unit, monthly rent may not exceed **\$975.00**
- renting a **2 bedroom** unit, monthly rent may not exceed **\$1,096.88**
- renting a **3 bedroom** unit, monthly rent may not exceed **\$1,218.75**
- renting a **4 bedroom** unit, monthly rent may not exceed **\$1,316.25**
- renting a **5 bedroom** unit, monthly rent may not exceed **\$1,413.75**

For **Lower Income** Households:<sup>12</sup>

- renting a **0 bedroom** unit, monthly rent may not exceed **\$1,023.75**
- renting a **1 bedroom** unit, monthly rent may not exceed **\$1,170.00**
- renting a **2 bedroom** unit, monthly rent may not exceed **\$1,316.25**
- renting a **3 bedroom** unit, monthly rent may not exceed **\$1,462.50**
- renting a **4 bedroom** unit, monthly rent may not exceed **\$1,579.50**
- renting a **5 bedroom** unit, monthly rent may not exceed **\$1,696.50**

In addition, for any Lower Income Household renters whose income falls within the following guidelines, it is **optional** for the agency to require that **affordable rent not exceed 30 percent of the gross income of the household**.<sup>13</sup>

- **1 person households** whose income is between **\$40,950** and **\$57,400**
- **2 person households** whose income is between **\$46,800** and **\$65,600**
- **3 person households** whose income is between **\$52,650** and **\$73,800**
- **4 person households** whose income is between **\$58,500** and **\$82,000**
- **5 person households** whose income is between **\$63,180** and **\$88,600**
- **6 person households** whose income is between **\$67,860** and **\$95,150**
- **7 person households** whose income is between **\$72,540** and **\$101,650**
- **8 person households** whose income is between **\$77,220** and **\$108,250**

For **Moderate Income** Households:<sup>14</sup>

- renting a **0 bedroom** unit, monthly rent may not exceed **\$1,876.88**
- renting a **1 bedroom** unit, monthly rent may not exceed **\$2,145.00**
- renting a **2 bedroom** unit, monthly rent may not exceed **\$2,413.13**
- renting a **3 bedroom** unit, monthly rent may not exceed **\$2,681.25**
- renting a **4 bedroom** unit, monthly rent may not exceed **\$2,895.75**
- renting a **5 bedroom** unit, monthly rent may not exceed **\$3,110.25**

In addition, for any Moderate Income Household renters whose income falls within the following guidelines, it is **optional** for the agency to require that **affordable rent not exceed 30 percent of the gross income of the household**.<sup>15</sup>

- **1 person households** whose income is between **\$75,075 and \$81,900**
- **2 person households** whose income is between **\$85,800 and \$93,600**
- **3 person households** whose income is between **\$96,525 and \$105,300**
- **4 person households** whose income is between **\$107,250 and \$117,000**
- **5 person households** whose income is between **\$115,830 and \$126,350**
- **6 person households** whose income is between **\$124,410 and \$135,700**
- **7 person households** whose income is between **\$132,990 and \$145,100**
- **8 person households** whose income is between **\$141,570 and \$154,450**

**For purposes of determining Affordable Rent, “Rent”** is an average of estimated housing costs for the next twelve months. **“Rent”** includes the total of monthly payments for all of the following:<sup>16</sup>

- Use and occupancy of a housing unit and land and facilities associated therewith.
- Any separately charged fees or service charges assessed by the lessor which are required of all tenants, other than security deposits.
- A reasonable allowance for utilities not included in the above costs, including garbage collection, sewer, water, electricity, gas, and other heating, cooking, and refrigeration fuels. Utilities does not include telephone service. Such an allowance shall take into consideration the cost of an adequate level of service.
- Possessory interest taxes or other fees or charges assessed for use of the land and facilities associated therewith by a public or private entity other than the lessor.
