## Solar Generator Rebate Qualifications:

- Applicant must be a **Moreno Valley Utility residential customer**.
- Applicant must be enrolled in the MVU **Medical Baseline Program**.
- A valid proof of purchase with the purchase date must be submitted with this application.
- All documentation must be submitted within 90 days of purchase to be eligible for rebate.

## Solar Generator Rebate Details:

- **Rebate Amount:** Up to \$500
  - The rebate amount shall not exceed the cost of purchase.
  - Rebate amount excludes taxes, shipping, warranties, and additional add-ons
- **Eligible Equipment:** Portable solar generator systems that include both solar panels and battery storage (minimum capacity of 1 kWh).
- **Ineligible Items:** Gas-powered generators, standard battery packs without solar charging capability, used, refurbished, and resold equipment.
- **Rebate Limit:** One rebate per household.

# SOLAR GENERATOR REBATE PROGRAM APPLICATION REBATE TERMS & CONDITIONS

## 1. Eligibility:

- a. Applicant must be a current residential customer of MVU.
- b. Applicant must be enrolled in the Medical Baseline Program at the time of purchase and application.
- c. Only one rebate per household will be issued.

## 2. Qualifying Equipment:

- a. The portable solar generator must include both solar panels and battery storage capable of powering medical or mobility-related devices.
- b. The device must have a minimum capacity of 1 kWh.
- c. Used, refurbished, or resold units do not qualify. Gasoline or diesel-powered generators are not eligible.

## 3. Rebate Amount:

- a. The rebate amount is up to \$500.
- b. Rebate amount cannot exceed the total purchase cost (excluding taxes, shipping, warranties, and additional add-ons).
- c. Rebates are issued as a one-time credit or check and are subject to available program funds.

## 4. Application Requirements:

- a. Application must be submitted within 90 days of purchase.
- b. A complete application includes:
  - i. Proof of purchase (sales receipt or invoice)
  - ii. Product specifications showing eligibility
  - iii. Proof of current Medical Baseline enrollment
- c. Incomplete or illegible applications will not be processed.

## 5. Processing and Payment:

- a. Rebates will be processed on a first-come, first-served basis while program funds remain available.
- b. Allow 8 weeks for processing after submission of a complete application.
- c. MVU reserves the right to verify equipment purchase and installation prior to issuing payment.

## 6. Program Limitations:

- a. Funding is limited and subject to change or discontinuation without prior notice.
- b. MVU does not endorse, recommend, or warrant any specific brand, manufacturer, or dealer.
- c. Customers are responsible for proper use, maintenance, and storage of equipment.
- d. MVU is not liable for any damages, losses, or injuries resulting from the use or misuse of the equipment.

## 7. Audit and Verification:

- a. MVU reserves the right to inspect and verify qualifying purchases before or after rebate issuance.
- b. False, misleading, or fraudulent information will result in denial or repayment of rebate funds.

## 8. Tax Responsibility:

- a. Rebates may be considered taxable income. Customers are responsible for any applicable taxes or reporting requirements.

## 9. Program Modification or Termination:

- a. MVU reserves the right to modify program terms, rebate amounts, or eligibility requirements at any time without notice.

## 10. Acceptance of Terms:

- a. Submission of an application constitutes the applicant's acknowledgment and acceptance of these Terms & Conditions.

### TAX LIABILITY:

- Moreno Valley Utility will mail rebate checks within 8 weeks of an approved application.
