RULES AND PROVISIONS FOR PARTICIPANTS

The Movin thru MoVal Mobile Recreation Program provides recreation programming for children who are in Kindergarten - 6th grade. Program participants will enjoy a variety of recreational and enrichment activities, sports, and homework help.

I agree to adhere to the following program rules:

1. All participating children must sign themselves in and out each time of attendance using their first and last names.
2. Mobile Recreation is a drop-in/out program and children are allowed to sign themselves in and out of the program without a parent/guardian present. This is a non-parent participation program.
3. Mobile Recreation will be canceled due to inclement weather and on major holidays. The status of the program can be checked at any time by calling the Field Conditions Hot Line at (951)413.3730.
4. All members, parents, and guardians are expected to be respectful to staff, volunteers, participants, parents, property, equipment, and facilities. Failure to adhere to the aforementioned may result in your child's suspension and/or expulsion from the program.
5. Property such as cell phones, mp3 players, and hand held video games must remain inside child's backpack during program hours.
6. Skateboards, scooters, skates, and bikes are not to be used during programming hours.
7. The City of Moreno Valley is not responsible for lost, stolen, damaged, or misplaced items.
8. Foul language and Public Displays of Affection (PDA) will not be tolerated at any school, park or facility. Failure to adhere may result in discipline, suspension and/or expulsion from the program.
9. Beginning five minutes after the end of program time each day, participants who are still at Mobile Recreation will be charged \$1/per minute late fee. After one hour, if your child has not been picked up, the City of Moreno Valley Police Department will be contacted and your child will be released into their custody.
